- 4. The school shall appoint only qualified and eligible staff as per qualification laid down in the rules.
- 5. Service agreement is executed with the staff as per norms generally accepted by the State Government concerned.
- 6. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
- 7. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

8. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.

The admission in the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.

- No unrecognized classes shall run within the premises of the school or outside in the same name of school.

- 2. Qualified teachers presently appointed on adhoc/part-time basis be considered for appointment on regular basis in the prescribed grade.
- 3. The school is required to designate teachers as PRTs/TGTs and fix their pay accordingly.
- 4. The school is required to upgrade the library, lab and playground as per norms of the Board.
- 5. School should ensure proper drinking water facilities, sanitaries and toilet facilities within the school campus.
