Sub: Approval of Syllabus for Middle Classes (I-VIII)

Dear Sir/Madam,

With reference to your application dated 28.06.2007 and subsequent correspondence with the school / inspection of the school in this regard, I am directed to convey the grant for Provisional approval of the Competent Authority of the Board for Middle Classes syllabus for a period of three years w.e.f. 01.04.2008 to 31.03.2011.

The above sanction is subject to fulfillment of following conditions:

1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT for the Middle Classes.
2. The grant for approval of syllabus of the middle classes does not in any way imply any obligation on the part of the Board to affiliate the Secondary Classes (IX-X).
3. The approval will also be subject to the condition that the school will make a fresh application for Provisional Affiliation of the Secondary Classes (IX-X) to the Board on line through CBSE website www.cbseaff.nic.in or www.cbse.nic.in in accordance with the rules and condition for Provisional Affiliation when classes VIII has been started.
4. The school shall appoint only qualified and eligible staff as per qualification laid down in the rules.
5. Service agreement is executed with the staff as per norms generally accepted by the State Government concerned.
6. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
7. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

8. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
9. The admission in the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
10. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
11. The school will abide itself by the rules and conditions for affiliation as given in the Affiliation Bye Laws of the Board.
12. Code Number allotted to your school is **830220**. This may please be noted and quoted in all future correspondence with the Board.
13. Reserve Fund be maintained in the joint name of the Secretary, CBSE and the School Authorities in accordance with the enrolment in the school from time to time.
14. Other conditions as per Annexure 'A'

Conditions for immediate compliance:

1. The school is required to ensure payment of salary DA and other admissible allowances at par with the corresponding categories of employees working in the State Govt. schools as per Affiliation Bye-laws and submit the photocopy of acquittance roll for the month of August - Sept., 2008.
2. Qualified teachers presently appointed on adhoc/part-time basis be considered for appointment on regular basis in the prescribed grade.
3. The school is required to designate teachers as PRTs/TGTs and fix their pay accordingly.
4. The school is required to upgrade the library, lab and playground as per norms of the Board.
5. School should ensure proper drinking water facilities, sanitarries and toilet facilities within the school campus.
